
## New vets mean increased CVSO business

Through September, the Dane County Veterans Service Office has seen an increase in business compared to the same time in 2006. Much of our increase is due to newly returning combat veterans. Forty-five percent of veterans new to our office are Operation Iraqi Freedom or Operation Enduring Freedom veterans. In some cases, our young men and women have served in both conflicts.

Other areas of increase have been with walk-in activity, veterans new to our office, but not necessarily new veterans, and increased contacts from appointments and outreach sites. Walk-in activity at our office has increased nearly 7 percent from 2006. A dramatic increase is shown in the area of those entirely new to our office; we are up 50 percent from 2006! Overall, we have seen an increase of almost 16 percent over last year at this time with respect to those served through appointments, walk-ins, and at outreach sites throughout Dane County.

As business increases, so does the need to make sure



that veterans call for appointments. Appointments will ensure that a service officer is available to help meet the needs of the veteran. We look forward to continuing our challenge of serving veterans and their families the most efficient way possible to help them obtain every benefit that they are entitled to receive. Ever wondered what kind of gesture might further pay tribute to a deceased loved one's military service? Even with a headstone or marker that briefly describes the veteran's service in the armed forces, one can further pay tribute with a flag holder. Families of deceased veterans whose grave sites do not have flag holders may want to obtain one in time for Veterans Day.

Many veterans organizations, such as the VFW or American Legion, often go through the cemeteries on Memorial Day, 4th of July and Veterans Day to place flags at the veterans' grave sites. High-quality, bronze flag holders are available at the Dane County Veteran Service office for \$21.00 each. These come in different styles, depending on the period of service.

Since we do not mail these out to customers our flag holders are only available for purchase at our office, located at the Alliant Energy Center. No appointment is necessary to get one, so just drop by at your convenience during our regular business hours: 7:45 to 4:30, Monday through Friday.

# Federal VA contracting for long term care

The U.S. Department of Veterans Affairs has been providing nursing home care to veterans for over 41 years. The Veterans Millennium Health Care and Benefits Act, Public Law 106-117, made important changes to the VA's nursing home program in an effort to address the growing need for long-term care among our most severely service connected disabled veterans. The Act had required that the VA provide nursing home care to veterans with a service connected disability rating of 70 percent or greater, when the need for care was related to a condition of their service and for those that were receiving nursing home care in a VA nursing home. It also includes those that are 60 percent service-connected disabled and are classified as unemployable or permanently and totally disabled.

The Veterans Administration, to keep pace with the demand for long-term care services for its veterans, enters into long-term care contracts with private nursing homes. The private nursing home must meet compliance issues to qualify. The VA contracted facility is paid in full at the contracted rate eliminating patient liability. The veteran keeps all of their income to include service connected compensation. State veterans homes have been excluded from entering into these contracts with the federal VA, which meant the veteran would be liable for care charges otherwise covered through a private nursing home VA contract.

The federal VA has partnered with state veterans homes to provide services to veterans in need of long-term care services. The federal VA provides grants to states for a portion of construction, renovation and operating costs. It is this federal assistance that has enabled the State of Wisconsin to expand services from its first state veterans home at King to the new state veterans home in Union Grove and likely in a few years to the Chippewa Falls area. The federal VA also pays a small daily per diem to the state for each veteran it cares for.

In May, 2007, Public Law 109-461, Section 211, provided VA authority to pay State Veterans Homes the prevailing rate or the home's daily cost of care, whichever is less, for veterans in need of long-term care services and who are 70 percent service connected, need long-term care as a result of their service connected condition or are 60 percent service connected disabled and unemployable or permanently and totally disabled. A July 23, 2007 response to U.S. Senator Russell D. Feingold from VA Secretary R. James Nicholson conveys that the "VA is developing the regulations that are necessary to implement the provisions of section 211." "...once regulations and rates are finalized, retroactive payments will be made to State Veterans Homes." Stakeholders continue to wait for the federal VA to promulgate rules.

## Women veterans conference

On September 29, the first Women Veterans Conference was held at Ft. McCoy with 160 participants attending spanning eras from WWII, Korean War, Vietnam veterans through current active duty personnel. The theme of the conference was "WOMEN VETER-ANS – PAST, PRESENT AND FUTURE."

The conference was sponsored by Wisconsin Dept. of Veterans Affairs and organized by a committee of women veterans representing several veterans service organizations including Dane County Veterans Service Office and with active duty, National Guard and reserve service members.

The special guest speaker was Dr. Betty Moseley Brown, associate director of the US Department of Veteran Affairs Center for Women Veterans who traveled from Washington to participate in the conference. Moseley Brown talked about the history and demographics of women veterans.

The second guest speaker was Maj. Cynthia Rasmussen of Ft. McCoy. Rasmussen is a combat operational stress control officer who talked about "Coming Home from War: A Community Response to Our Veterans." She also talked about several key topics of specific interest to women veterans, including reintegration, PTSD, sexual assault, depression, and suicide among women veterans.

Other speakers included Dr. Amy Banks, from Stone Center of Wellesley College in Massachusetts who spoke about heart disease in women, and the physi-

cal and emotional causes of stress and how they relate to heart disease.

Break-out sessions in the afternoon provided information on federal and state benefits, education benefits, PTSD, personal finances, investments and retirement. Speakers for the afternoon sessions on benefits included Holly Hoppe, Oconto CVSO; Chris Jordan, Walworth CVSO; and Chris Scoville, Asst. Dane CVSO.
