Increased access to VA health care

On January 28, the National Defense Authorization Act of 2008 was signed into law. One section of this document increases access to VA health care for new combat veterans. Prior to the change, veterans had a 2-year window to apply for enrollment into the VA Health Care System regardless of their income status. This window has now been increased to 5 years!

- Veterans who served in a combat theater are eligible for entry into the VA Health Care System for 5 years post separation from their qualifying active duty period if they were separated from active duty on or after January 28, 2003.
- Those separated from a qualifying active duty period before January 28, 2003, who apply for VA health care access on or after January 28, 2008, are eligible to apply for this enhanced benefit until January 27, 2011.

Qualifying combat-veterans who were previously denied entry into the VA Health Care System due to being outside of the old 2-year window are encouraged to reapply.

Access to VA health care is available to noncombat veterans as well; however, access is not guar-

anteed. In general, all non-combat veterans without compensable VA service-connected disabilities are subject to having their income scrutinized. As a result, income that is too high

often becomes a barrier to receiving VA health care benefits.

I highly recommend that all combat veterans who meet the above criteria apply for their VA health care benefits during their enhanced eligibility period. All non-combat veterans who may qualify for medical care are encouraged to apply as well. "Honor deceased veterans by serving living veterans"



VA dental care window now 180 days

Effective January 28, 2008, all veterans who served on active duty for at least 90 days are eligible to receive one-time dental treatment through the VA for 180 days after separation from active duty. Your DD214 must show that you did not receive dental care within the 90-day period prior to separation. If you meet all of the necessary requirements, you must

enroll into the VA Health Care System within 180 days after separation from your qualifying period of active duty to be eligible for dental service.

Economic stimulus payments for recipients of veterans benefits

For people receiving benefits from the Department of Veterans Affairs for compensation, pension or survivors' benefits, the IRS and Treasury will be working closely with the Department of Veterans Affairs along with beneficiary organizations to ensure that all eligible individuals know what to do to receive a stimulus payment.

Normally, certain veterans' payments are not subject to income tax. However, the economic stimulus law passed in February, 2008, contains a special provision allowing recipients of certain veterans' benefits to count those benefits toward the qualifying income requirement of \$3,000 and thereby qualify for the stimulus payment. For purposes of meeting the qualifying income requirement, the following benefits need to be reported in any combination on Line 14a of the Form 1040A or Line 20a of Form 1040:

• The sum of veterans' disability compensation, pension or survivors' benefits received from the Department of Veterans Affairs in 2007. People are allowed to estimate their annual benefit by taking

- their monthly annual veterans' benefit, multiplying it by the number of months during the year they received benefits, and entering the number on Line 20a of Form 1040 or Line 14a of the Form 1040A.
- People should note that Line 14a of the Form 1040A and Line 20a of Form 1040 are designated for Social Security. However, these lines should also be used to include any veterans' benefits.

Basic Eligibility Requirements. Individuals or families must have at least \$3,000 in qualifying income, which can be income from or in combination with Social Security benefits, Veterans Affairs benefits, Railroad Retirement benefits or earned

- People must have valid Social Security numbers.
- People cannot be claimed as dependents or eligible to be claimed as dependents on another's tax return.
- The payment does not have to be declared as income for 2008.

VA's suicide hot line begins operations

WASHINGTON - To ensure veterans with emotional crises have round-the-clock access to trained professionals, the Department of Veterans Affairs (VA) has begun operation of a national suicide prevention hot line for veterans.

"Veterans need to know these VA professionals are literally a phone call away," said Secretary of Veterans Affairs Jim Nicholson. "All service members who experience the stresses of combat can have wounds on their minds as well as their bodies. Veterans should see mental health services as another

benefit they have earned, which the men and women of VA are honored to provide."

The toll-free hot line number is 1-800-273-TALK (8255). VA's hot line will be staffed by mental health professionals in Canandaigua, N.Y. They will take tollfree calls from across the country and work closely with local VA mental health providers to help callers. To operate the national hot line, VA is partnering with the Substance Abuse and Mental Health Services Administration.

Notch Babies

Born in 1917 - 1921

Notch babies is the term used to refer to retirees who were born from 1917 through 1921 and who may be receiving Social Security benefits lower than those with comparable earnings born from 1912 through 1916. The issue of notch babies periodically surfaces in the form of mailing campaigns soliciting donations to fix the alleged notch.

The controversy started in 1972 when Congress made an error when calculating the new cost-of-living adjustments. The error resulted in some beneficiaries receiving greater benefit levels than intended. In 1977, Congress corrected the mistake by creating a formula to gradually lower the unintentionally high benefits for people nearing retirement. However, because Congress did not want to lower benefits for people who had already retired, people born between 1912 and 1916 were overpaid.

The majority of older American advocacy organizations do not support the lobbying effort to introduce legislation to fix the alleged notch because it would threaten the solvency of the Social Security System and would simply create a new "notch" consisting of individuals born after 1921. There are some organizations, however, that are currently soliciting financial contributions from notch babies in order to support their lobbying efforts.

If you receive calls or mailings from organizations urging you to help the notch babies by sending donations, know that federal legislation has been proposed in the past to no result and that it is extremely unlikely that the legislation would ever pass. The creation of notch babies was not the result of beneficiaries being underpaid; rather it has to do with retirees born between 1912 and 1916 being overpaid.
